

# Terms and Conditions for PhiloDanceophy Limited

Effective Date: April 19, 2025

## 1. Eligibility and Registration

- Participation is open to individuals aged 18 and above. Participants under 18 require the consent of a parent or legal guardian.
- Participants must complete the required registration forms and provide accurate personal information, including health and emergency contact details.
- PhiloDanceophy Limited reserves the right to deny registration or participation based on capacity, suitability, or conduct.

## 2. Bookings and Payments

- Bookings must be made via our official channels. Payment confirms the booking and agreement to these terms.
- Accepted payment methods include credit/debit cards, bank transfer, and online payment systems.
- Payment plans may be offered at the discretion of PhiloDanceophy Limited and require a signed agreement.
- Late payments may result in additional charges or booking cancellations.

## 3. Cancellations, Rescheduling, and Refunds

- Participants may cancel bookings more than 48 hours in advance for a full refund or reschedule.
- Cancellations within 48 hours are non-refundable except in exceptional circumstances (e.g., medical emergencies) with supporting documentation.
- Refunds are processed within 14 business days.
- PhiloDanceophy Limited may cancel or reschedule any class or event. If so, affected clients will be offered a refund or alternative.

#### 4. Memberships and Packages

- Memberships grant access to specified services and are subject to terms published at the time of purchase.
- All packages and memberships are personal, non-transferable, and non-refundable unless otherwise stated.
- Packages must be used within their validity period unless an extension is approved.

#### 5. Conduct and Behaviour

- All participants are expected to respect instructors, staff, and fellow dancers.
- Discriminatory, abusive, or unsafe behavior will result in removal from the premises and possible permanent ban without refund.
- Participants must follow studio rules including attire, punctuality, and phone usage.

#### 6. Health, Safety, and Participant Responsibility

- By participating, you declare that you are medically fit and able to engage in physical activity.
- You must inform instructors of any injuries or medical conditions.
- PhiloDanceophy Limited staff may deny participation if they believe it would be unsafe.
- Participation is at your own risk. We are not liable for injuries unless due to proven negligence.
- All participants must comply with our health and safety policies, including hygiene and use of equipment.

#### 7. Intellectual Property

- All choreography, teaching materials, video content, and branding are the intellectual property of PhiloDanceophy Limited or its instructors.
- You may not record, reproduce, or distribute class content without prior written consent.
- Use of PhiloDanceophy Limited's materials for commercial or public purposes is strictly prohibited

without a license.

- We may film or photograph sessions for promotional and educational use. You will be asked to sign a media release form.
- If you do not wish to appear in media, please notify us in advance in writing.
- Unauthorized recording by participants is strictly prohibited.

## 9. Limitation of Liability

- PhiloDanceophy Limited is not liable for personal injury, loss, or damage unless due to negligence or breach of legal duty.
- We are not responsible for the loss or theft of personal belongings on our premises.
- Participants must ensure they have appropriate insurance for personal injury and property damage.
